Public Comments on Items Not Appearing on the Agenda

Any citizen desiring to speak on a matter not appearing on this Agenda may do so under Public Comments at such time the President of the Board will request remarks from the audience. Those comments, by State Law, are limited to items of interest to the public that are within the subject jurisdiction of the Board of Directors. You should be aware that the law prohibits the Board from discussing or acting at this meeting on items not on the Agenda except for very limited situations. Those situations are:

- 1. If an emergency exists. This generally requires the existence of work stoppage or a crippling disaster, which impairs the public health or safety. This requires the affirmative vote of three members of the Board; or
- 2. The Board finds that the need to act arose after the Agenda was posted. If five Board Members are present, this action will require a 2/3 Vote or four votes. If only three or four Board Members are present, this action will require a unanimous vote of all Board Members present; or
- 3. This matter had been placed on Agenda and posted previously at prior meeting within the last five-days and was continued until this meeting.

To provide an opportunity for all members of the public who wish to address the Board, a time allocation of 5 minutes for each individual speaker and 30-minutes total time for public testimony on an item has been established by the Board of Directors.

3.1 Approval of Hayward Community Garden Conceptual Plan and Phase 1 Improvements *Executive Summary*: The Board will receive a presentation of the Hayward Community Garden concept plan and proposed Phase 1 improvements.

Financial Impact: None.

Staff Recommendation: Staff recommends the Board of Directors receive a presentation of the Hayward Community Garden concept plan and proposed Phase 1 improvements and approve the plan as proposed, or provide an alternate recommendation.

Description of Item: The Hayward Community Garden project (CIP No. 2-034C&D) is included in the current Three-Year Capital Improvement Program. The project provides for the development of a master plan and installation of Phase 1 improvements for the community garden site located at Whitman Street and Berry Avenue.

The District hired RRM Design Group to design the garden master plan. A project kick-off meeting and site tour was conducted on May 10, 102 with District Staff, RRM, City of Hayward Staff, UC Cooperative Extension staff, and Hayward Community Garden members to gather information about potential garden improvements. A subsequent design meeting was held on July 18, 2017 in order to develop a pre, 2017.

The concept plan, which includes approximately 200 garden plots measuring 20'x20', some raised beds, a structure to accommodate outdoor classes and a produce counter/seed library, storage shed and compost/mulch areas, "kiwi tunnel" feature, nature play areas, picnic area, central 14' wide multi-use path, and perimeter walking path, and fences and gates, was received favorably by the attendees. Additional suggestions included a consistent design vocabulary throughout the garden inclusion of food education into programming, rain water harvesting, an on-site caretakers' office, and a tool lending library.

The proposed Phase 1 improvements will occur mainly near the Whitman Street entrance and will include a number of garden plots, fencing and gates, small picnic area, storage shed, compost/mulch area, a portion of the 14' wide multi-use path, irrigation, and may include additional amenities suggested in the Work Session if the budget allows.
