Approval of a Task Order for Geotechnical Services for the San Lorenzo Community Park - Phase 2 and Community Center Renovation Projects

Executive Summary:

The Board of Directors will consider approval of a Task Order with Ninyo & Moore Geotechnical Engineers, to support ongoing design and construction phases at San Lorenzo Community Park Renovation - Phase 2 (CIP No. 6-138.01) and San Lorenzo Community Center Renovation (CIP No. 6-080.01) projects.

Financial Impact:

The Five-Year Capital Improvement Program 2020-2025 includes funding for the San Lorenzo Community Park Renovation - Phase 2 (CIP No. 6-138.01) and San Lorenzo Community Center Renovation (CIP No. 6-080.01) projects. There are sufficient funds to award the Task Order in the amount of \$71,000.

Staff Recommendation:

By motion, approve a Task Order with Ninyo & Moore Geotechnical Engineers, to provide professional geotechnical engineering services for the ongoing projects San Lorenzo Community Park Renovation - Phase 2 (CIP No. 6-138.01) and San Lorenzo Community Center Renovation (CIP No. 6-080.01) projects.

Description of Item:

In 2013, the geotechnical engineering firm Ninyo & Moore was retained to provide professional services for the San Lorenzo Community Park - Phase 1 project. Their geotechnical report dated December 9, 2013 was the basis for design work by RRM Landscape Architects, and their professional consultants.

On January 22, 2018, the Board approved Ninyo & Moore as one of five firms to provide on-call Geotechnical Engineering Services. Ninyo & Moore was approved to update their 12/9/13 geotechnical report for the continuing design work for the San Lorenzo Community Park projects as Task Order #2 dated July 1, 2019 under the on-call master agreement. The updated geotechnical report, dated September 20, 2019, is being used to support design development for the Phase 2 Park renovation and the Community Center renovation projects.

Staff is requesting Board approval of a final Task Order in the amount of \$71,000 to address two scope components covering both construction document review and construction administration. Ninyo & Moore will work with both RRM Landscape Architects, designers for the balance of the Phase 2 park renovation project, and Dahlin Group, architects for the Community Center renovation to review conformance of the construction documents with recommendations outlined in their geotechnical report. The scope of this Task Order also includes Ninyo & Moore's continued involvement during the construction phases for both projects.
